# TO APPROVE (A) GENERAL MINUTES AND (B) SUPPLEMENTARY MINUTES OF THE MEETINGS HELD ON THE $11^{\rm TH}$ MAY, 2023

The Minutes were proposed as correct (**A**) General Minutes by Councillor Billy Glynn and seconded by Councillor Paul Urquhart and (**B**) Supplementary Minutes by Councillor Paul Urquhart and seconded by Councillor Gareth sharp – with both sets of minutes formally agreed by the Members present.

#### 5. 122/23

#### PROGRESS REPORT ON MATTERS RAISED AT PREVIOUS MEETINGS

The Clerk referred to the following matters from previous Minutes:

- (1) Minute no: 9(A). 100/23 (page 3) in relation to the installation of a defibrillator in the Red Phone Box in Pantasaph. The Clerk advised Members that the local Health Board had located the defibrillator, whereby the unit had been placed in the Red Phone Box. The Clerk confirmed, that the project was now fully completed.
- (2) Minute no: 9(B). 101/23 (page 3) in relation to an Active Travel bid made by Flintshire County Council to the Welsh Government. The Clerk advised Members, that the County Council were still awaiting a decision from the Welsh Government.
- (3) Minute no: 10(A). 102/23 (1) (page 4) in relation to One Voice Wales' Annual General Meeting and in particular, seeking motions from neighbouring Town & Community Councils that this Council could consider supporting. The Clerk advised that a global e-mail had been sent by the local branch of the Society of Local Council Clerk's to the Clwyd Branch Membership. There had been no response.
- (4) Minute no: 10(B). 103/23 (page 4) in relation to a tree on this Council's land adjacent to Ysgol Y Llan, Whitford, that had been confirmed with ash die back disease. The Clerk recollected Members to a quotation received for the sum of £747.00, whereby Council had requested a second quotation. A second quotation had been received for £500.00 (plus VAT). The quotation had been sent to the Chair and Vice Chair of Council for consideration. The quotation was accepted whereafter the Clerk had issued a Work Order to Davies, Land & Sea, in Lloc.

The Clerk further advised, that the Headteacher of Ysgol Y Llan had requested the tree stump to remain as the School wished to create a carving.

The Clerk had forwarded the request to the Chair and Vice Chair of Council, together with the County Tree Officer. Both the Chair and Vice Chair agreed to the request, with the County Tree Officer offering no adverse comments. The Clerk further advised that the tree had been felled with the trunk remaining. **Members agreed the following:** (1) Confirmed the quotation acceptance of £500, from Davies, Land & Sea in Lloc (2) Confirmed the decision to allow the tree stump to remain.

(5) Minute no: 13. 112/23 (page 7) – in relation to speeding concerns on the A5026 Road – in the area of Carmel Cricket Club. The Clerk advised that following the May meeting a request had been sent to County Councillor Chris Dolphin, seeking that he arrange a traffic survey in the above area during the summer months.

The Clerk further advised, that County Councillor Dolphin had replied as follows: 'I sought a speed reduction within this area during the last Welsh Government directive concerning

speed reviews. This particular area, together with Pant Y Wacco did not reach the criteria. I did not, and do not now agree with these decisions. As requested, I will request a new speed survey at this location'.

# 6(B). 124/23 CLERK'S REPORT

(a) The Clerk advised in relation to a request received from the Headteacher of Ysgol Yr Llan in Whitford. Following the Work Order to remove the diseased tree the Headteacher had requested that the tree on Community Council land adjacent to the School was only cut above a certain height, as the School wished to utilise the remaining tree trunk for a sculpture. The request had been sent to the Chair and Vice Chair for a decision as the Company contracted were to complete the removal of the tree imminently.

Whilst the Chair and Vice Chair of Council had agreed to the request, the thoughts of the County Tree Inspector were also sought; who had no adverse comment. The contractor was notified as to the height of the trunk to be left in situ.

**Members agreed the following:** Confirmed the above decision.

**(b)** Councillor Joe Williams – attendance at One Voice Wales Training Course (Code of Conduct). The Clerk advised that he would forward a new list of training dates to Councillor Williams once received from One Voice Wales.

#### 6(C). 125/23

#### INTERNAL AUDIT REPORT (ADJ FROM MAY)

The Clerk recollected Members to a copy of the recently received Internal Audit report for year ending March 2023 - that had been sent to Councillors prior to the meeting.

#### **COMMUNITY AWARD (UPDATE)**

The Clerk advised that following notification to the Editor of the Five Villages Chronicle, that the Committee had been nominated for a Community Award, which had been accepted by this Council, a reply had been received accepting the award together with the names of nine members of the Committee. The Five Villages Chronicle wished the Chair of Council to present the Award at their Committee meeting to be held on Thursday 8<sup>th</sup> July.

Councillor Emma Warbrick advised Members that contact had been made with a local glass engraver which this Council had used previously and had quoted a cost of £15.00 for each engraving. Members were shown on screen a suggested glassware trophy at a cost of £9.99 each.

Members agreed the following: (1) The Clerk to issue a Purchase Order to The Trophy Store for nine items of glassware at £9.99 each – total cost £89.91 (2) To issue a Work Order to Karen Price for engraving nine glassware trophies at a cost of £135.00 (3) The Clerk to provide Councillor Richard Dolphin with a framed certificate.
